JWI ALSO ADDRESSES TRAINING AND EDUCATION AROUND GENDER PARITY AS IT RELATES TO SEXUAL HARASSMENT, WORKPLACE MISCONDUCT, AND CREATING SAFE AND EQUITABLE WORKPLACES.
